FEDERAL DISASTER DECLARATION FACT SHEET

OCTOBER 13, 2016

On October 10, 2016, President Obama issued a major disaster declaration for the State of North Carolina triggering the release of Federal funds to help individuals and communities recover from Hurricane Matthew that began on October 4, 2016, and continuing. **This disaster declaration has been amended as indicated below in bold.** Details of the disaster declaration and assistance programs are as follows:

Declaration Number: FEMA-4285-DR

Incident: Hurricane Matthew

Incident Period: October 4, 2016, and continuing

Individual Assistance (IA): (Assistance for individuals and households):

IA-Designated Counties: Beaufort, Bertie, Bladen, Columbus, Cumberland, Dare, **Duplin**, Edgecombe, **Gates**, Greene, Harnett, Hoke, Hyde, Johnston, Jones, Lenoir, Nash, **Pender**, Pitt, and Robeson, Sampson, Wayne, and Wilson Counties.

Public Assistance (PA): (Assistance for emergency work and the repair or replacement of disaster-damaged facilities):

PA-Designated Counties: Beaufort, Bertie, Bladen, Brunswick, Camden, Carteret, Chowan, Columbus, Craven, Cumberland, Currituck, Dare, Duplin, Edgecombe, **Gates**, Greene, Harnett, Hoke, Hyde, Johnston, Jones, Lenoir, Nash, New Hanover, Onslow, Pamlico, Pasquotank, Pender, Perquimans, Pitt, Robeson, Sampson, Tyrrell, Washington, Wayne, and Wilson

Counties for debris removal and emergency protective measures (Categories A and B), including direct federal assistance, under the Public Assistance program.

Hazard Mitigation (HM): (Assistance for actions taken to prevent or reduce long term Risk to life and property from natural hazards):

HM-Designated Areas: All areas in the State of North Carolina are eligible for assistance under the Hazard Mitigation Grant Program.

OTHER: Additional designations may be made at a later date if requested by the State and warranted by the results of further damage assessments.

Individuals in Beaufort, Bertie, Bladen, Columbus, Cumberland, Dare, Edgecombe, Greene, Harnett, Hoke, Hyde, Johnston, Jones, Lenoir, Nash, Pitt, and Robeson, Sampson, Wayne, and Wilson Counties can register with FEMA the following ways:
