Medicaid Pre-2008

Cost Sharing Structure

- Medicaid costs were shared between the feds and the states. (Still true.)
- North Carolina required counties to pay 15% of the State share.
- Cities paid nothing.

County Impact

- Rural, poorer counties were disproportionately burdened by the match requirement.
- Even wealthier counties felt the pressure of Medicaid.
- Counties lobbied heavily for "Medicaid relief."

All cities and most counties would be losing money from the Medicaid Swap, if not for Hold Harmless payments.





City Hold Harmless (G.S. 105-522)

- Article 44 was distributed 50% per capita; 50% point of sale.
 - City Hold Harmless payments mimic this distribution.
- Counties paid cities nearly \$317 million in CHH in FY 2022-23.


County Hold Harmless (G.S. 105-523)

- Some counties would have been better off paying for Medicaid and keeping the sales tax.
- Compromise to bring counties who would have been losers up to \$0 (break-even).
- **If you receive Hold Harmless:** You would be losing money from the Swap but the Hold Harmless pushes you to the break-even point.
- If you don't receive Hold Harmless: You are better off with the Swap! You gave up less tax revenue than you would have paid out in Medicaid costs.



Example: McDowell County


McDowell County's foregone tax revenue is now greater than its foregone Medicaid costs. This gap causes **hold harmless payments**.





Example: McDowell County

McDowell County no longer benefits from the Medicaid Swap. Without Hold Harmless payments, the County would have lost money every year since FY18.




Q: Why are my hold harmless payments so high?

A: Because the half cent you gave up has become extremely valuable.






Cities: It's Just the Economy

Counties: Medicaid + the Economy

- County Hold Harmless is especially prone to volatility in a bad economy.
- County Hold Harmless will get a double hit from lower spending and higher Medicaid costs.
- County Hold Harmless will likely decline more than other sales tax revenue in a bad economy.
